

Application for the use of the International Self-Assessment Tool for Organizational Health Literacy in Primary Health Care Services (OHL-PHC) and confirmation on fulfilling the conditions for using the tool

About the English version of the OHL-PHC

- The International Self-Assessment Tool for Organizational Health Literacy in Primary Health Care Services (OHL-PHC) was developed by the M-POHL Working Group on Organizational Health Literacy in Primary Care Services.
- It is owned by the WHO-Action Network on Measuring Population and Organizational Health Literacy (M-POHL) which is coordinated by the International Coordination Center (ICC) at the Gesundheit Österreich GmbH / Austrian National Public Health Institute, Stubenring 6, 1010 Vienna.
- The tool should be cited as: M-POHL Working Group on Organizational Health Literacy in Primary Care Services (2025): International Self-Assessment Tool for Organizational Health Literacy in Primary Health Care Services (OHL-PHC). M-POHL. Vienna.

Conditions for the use of the OHL-PHC

The use of the tool is bound to a set of rules for non-M-POHL OHL project partners:

1. Registration by filling in this application form is required to use the original English version or translated versions of the tools and the following conditions 2-7 must be accepted and guaranteed.
2. The use of the tool (e.g. assessment/evaluation, quality improvement, study, accreditation, teaching) must be non-commercial and in public interest. This rule includes that those using the tool, e.g. health care organizations, management, education/training institutions, consulting services, services for accreditation, regardless, whether they are non-profit or for-profit, are NOT allowed to charge others for the direct use of the tool.
3. Any licensing of the OHL-PHC - the entire tool or part of the tool - by third parties is prohibited.
4. Any translations of the tool must be provided to the ICC.
5. The ICC and the M-POHL OHL project partners can use the translated versions.
6. The tool must be cited in any publication resulting from the use of the tool.
7. Regarding publications based on the use of the tool, a pdf copy of publications must be provided to the ICC after publication.

The use of the instrument is free of charge.
